## 1. SCOPE

- 1.1 This document gives details of the fees involved in the Verification and Attestation Service as per General Rules RD-DP33-6001 (IC).

*NOTE: The fees mentioned here are also applicable to the issuance of Ministry of Interior - Civil Defence GHQ Certificate of Compliance to UAE Fire and Life Safety Code based on DCL Product Conformity Certificate.*

## 2. GENERAL DESCRIPTION

The fees are calculated based on the man-hours spent to carry out the required tasks given in the procedure, and multiplied by the official DCLD man-hour rate of Dhs 174/man-hour as provided for in DM Local Order 5/2001.

## 3. FEE CATEGORIES AND TERMS OF PAYMENT

All fees shall be paid to Dubai Municipality except those as mentioned in the table.
