

Administrative Resolution No. (329) of 2009

Concerning

Utilization of Children's City Facilities

The Director General of the Municipality:

- Upon review of the powers vested in us by the Decree of Establishing Dubai Municipality;
- Law No. (6) of 1997 Concerning Government Departments Contracts in the Emirate of Dubai; and
- upon the proposal of the Assistant Director General of Environment and Public Health Affairs

Resolved:

Article (1): The fees set forth in the Schedule to this Resolution, and approved by us, shall be collected from the parties wishing to utilize the facilities of the Children's City (theater, education rooms, multi-purpose halls, indoor and outdoor yards) for holding cultural or entertainment events or for photography, television or cinema filming or any other activities.

Article (2): The parties referred to in Article (1) of this Resolution shall enter into utilization contracts which will be drafted in accordance with the provisions of the Government Departments Contracts Law No. (6) of 1997. The contract shall specify the type, purpose, location and term of the utilization and the financial consideration payable for it. The contract shall also list the most important conditions required to be observed by such parties, including:

1. The purpose of utilization of the Children's City facilities shall not be inconsistent with the Islamic Sharia provision or with the Public Order, morals, culture and customs applicable in the Emirate of Dubai.
2. Not to use the facility the subject of the contract for any purpose other than the purpose agreed on in the contract.
3. To observe the legislations of the Department and the other applicable legislations applicable in the Emirate of Dubai.
4. The contracting party shall be liable for indemnity for any damages which may be sustained by the facilities of the City as a result of utilization.

Article (3): The chairman of the Children's City may organize promotional shows for certain entities such as schools, public welfare societies, summer camps and members of the Children's City at promotional rates reduced by not more than (10%) of the consideration determined for such shows.

Article (4): This Resolution shall come into effect as of the date of its issuance. The chairman of the Children's City shall take the necessary procedures for implementing it.
