## 1. SCOPE

This document gives details of the fees involved in the granting of the Type 1B Product Conformity Certificate as per the General Rules for the DM Third Party Type 1 Product Certification, DM-DCLD-RD-DP32-5001 (IC).

## 2. GENERAL DESCRIPTION

The fees are calculated based on the man-hours spent to carry out the required tasks given in the procedure, and multiplied by the official DCLD man-hour rate of Dhs 174/man-hour as provided for in DM Local Order 5/2001.

## 3. FEE CATEGORIES AND TERMS OF PAYMENT

All fees shall be paid to Dubai Central Laboratory Department, Dubai Municipality.

3.3	Testing Fees	These fees are for the cost of testing of the products in accordance with the requirements of the relevant Specific Rules.	The fee shall be paid in accordance with the terms of payment of the independent laboratory.	As per Fee schedule of the lab.
3.4	Evaluation and Reporting Fee	This fee shall cover the cost of evaluation of the results and preparation of the final report and recommendation for certification.	The fee shall be billed together with the Sampling Fee and must be paid prior to the conduct of sampling.	AED 3132 per application
3.5	Certification Fee	This fee will be applicable only after a satisfactory result is obtained in the evaluation. The fee will cover the administrative costs in the preparation, issuance and maintenance of the conformity	The fee shall be paid prior to the issuance of the Certification.	AED 1044 per application
