## 1. INTRODUCTION

- 1.1 This document prescribes the specific rule for certification of the product(s) as identified herein, in accordance with the requirements of DM Third Party Product Certification Scheme Through Factory Assessment, taking into consideration the applicable normative references and standard specification, in addition to the requirements for conformity evaluation, as stated below.
- 1.2 The applicant/client shall comply with this specific rule, and to all provisions under the "General Rule for DM Third Party Product Certification Scheme Through Factory Assessment" DM-DCLD-RD-DP21-2001 (IC).
- 1.3 This specific rule is an integral part of the general rule, and both shall always be read together.

### 2 SCOPE

- 2.1 This Specific Rules covers the requirements for the certification of autoclaved aerated concrete masonry units that will be used in the Emirate of Dubai.
- 2.2 This specific rule does not -by itself- permit the use of the below product in the construction sites. However, it does provide the necessary general conformity assessment criteria, which are required for the evaluation and issuance of the certification and the authorization of the use of the DCLD Conformity Mark. Other relevant requirements issued by the regulatory bodies if any; shall always be fulfilled.

- In addition to the definitions given in DMS 1: Part 3 and the General Rule of the scheme [DM-DCLD-RD-DP21-2001 (IC)], the following shall apply:-
  - 4.1.1 Standard Specification TG 01-2024 Technical Guide for Blocks used in Construction Sites in the Emirates of Dubai Part 3: Autoclaved Aerated Concrete Masonry Units.

## **5 REQUIREMENTS FOR INITIAL CERTIFICATION**

- 5.1 The process of application, initial assessment and product sampling shall be in line with the related provisions in the general rule and the standard specifications.
- 5.2 The factory shall have a laboratory with the following testing equipment as a minimum:
  - a. Compressive testing machine
  - b. Dimensional measuring instruments
  - c. Chloride and Sulphate
  - d. Density
- 5.3 Factory Production Control System (Internal Product Quality Assurance Plan).

  The factory shall have an internal product quality assurance plan giving details of the tests to be carried out at the factory, which shall conform to DM-DCLD-RD-DP21-2090 (IC).
- 5.4 Product Evaluation and testing
  - 5.4.1 Samples collected as per Annex G (AAC) of the Standard Specification shall be subjected to in plant and independent test for the following properties:
    - 5.4.1.1 Gross Density
    - 5.4.1.2 Chloride and Sulphate content
    - 5.4.1.3 Drying Shrinkage
    - 5.4.1.4 Thermal Conductivity
    - 5.4.1.5 Dimensional Tolerances
    - 5.4.1.6 Normalized Compressive Strength
  - 5.4.2 If the factory is outsourcing the routine tests to an accredited laboratory, in-plant tests may be waived, provided that records of routine tests are available and in-line with the frequency of testing as per DM-DCLD-RD-DP21-2090 (IC).

- 6.5 Appeals, disputes, and complaints shall be in line with the relevant provisions in the General Rule.
