Practicing the Activity of Engineering Management Services for Projects and Technical Feasibility Studies

- 1. Such offices shall not have the right to cancel the role of the consulting office responsible for the implementation of work.
- 2. The consultant that designs the project, in whose name the plans are licensed, and that supervises the implementation of work, shall be fully responsible if they fail to inform the Municipality of the office assigned by the owner to manage the project.
- 3. Pursuant to Articles Nos. (4) and (6) of Administrative Resolution No. (51) of 1994 on the issuance of the Executive Regulations for Local Order No. (89) of 1994 on regulating the practice of the engineering consulting profession in the Emirate of Dubai, local engineering offices, that carry out activities of (civil engineering and architectural engineering consulting services), registered under No. (742101-742108) according to the activities list of the Department of Economic Development, may carry out the activity of [engineering management services for projects] according to the class of the consulting office. Such offices may not carry out the activity for a class higher than the registered one.
- 4. Standards necessary for licensing the activity of [engineering management services for projects], registered under No. (742138) according to the activities list of the Department of Economic Development, shall be similar to those standards necessary for the activity of class 1 engineering offices (class of unlimited floors) contained in Local Order No. 9 of 1994 and the committee's decisions in terms of technical personnel, spaces and standards required according to the volume of work
- Branches of foreign engineering offices that carry out the activity shall meet the same standards necessary for class 1 (unlimited floors), provided that the responsible manager shall have at least 15 years of experience.
- 6. All national engineers who are specialized in any engineering major shall have the right to establish an office to practice the activity of [engineering management services for projects], according to the major specialized in by the license holder.

- 7. All engineering offices that practice the activity of [engineering management services for projects], registered under No. (742138) shall regularize their status within one year as of the date on which this Circular is issued, provided that the necessary technical personnel are provided during such period.
- 8. All engineering offices, licensed to practice the activity of (civil engineering and architectural engineering consulting services), registered under No. (742101-742108) according to the activities list of the Department of Economic Development, that carry out their activities in violation of Local Order No. (89) of (1994) and its Executive Regulations, in addition to the provisions of Clause No. (3) of this Circular, shall regularize their status as of the date on which this Circular is issued.
- 9. The engineering consulting office that prepares the design and supervises the implementation of the project shall be fully responsible for informing the Municipality of the office assigned by the owner to manage the project in accordance with the requirements contained in Local Order No. (89) of (1994) and its Executive Regulations, in addition to the provisions of this Circular.

Testing of Technical Personnel

All technical structural engineers registered with local engineering offices, branches of international offices, and offices that practice the activity of [engineering management services for projects] shall be tested according to Table No. (2) of the Executive Regulations of Local Order No. (89) of (1994) and the provisions of this Circular.
