1. INTRODUCTION

This document gives details of the fees involved in the certification schemes for voluntary products including other products such as steel couplers, ACP and 3D Printing. This certification is under the factory assessment scheme, DM-DCLD-RD-DP21-2001 (IC).

2. SCOPE

The fees are calculated based on the man-hours spent to carry out the required tasks given in the procedure and multiplied by the official DCLD man-hour rate of AED 174/man-hour as per DM Local Order 5/2001.

All fees shall be paid to Dubai Municipality except those mentioned in the table.
