1 Purpose

The potential danger in the use of cranes, lifts, hoists, and other lifting equipment is well known. The causes of accidents in lifting operations result from improper maintenance, non-provision of warning systems, poor upkeep of safety standards, overloading, unsafe slinging practices, and other unsafe operations. To reduce accidents resulting from equipment failure, a periodical test and certification of equipment by competent person is required.

Dubai Local Order No. 61/1991 requires the Occupier/Employer to ensure that the workplace, plant, and equipment are always safe.

2 Scope

This technical guideline applies to all establishments where cranes, hoists, lifts & other lifting equipment are used within the Emirate of Dubai.

3 Definitions

4 Requirements

- 1- Cranes, hoists, lifts, lifting equipment and gears, forklifts, etc. used in factories, construction sites, hotels, and other workplaces shall be tested and certified by a third party accredited by Emirates International Accreditation Center (EIAC) once every 12 months.
- 2- Only technically qualified and experienced persons by the Emirates International Accreditation Center (EIAC) shall examine, test, and certify cranes and other lifting equipment.
- 3- The company/competent person seeking accreditation shall comply with the following:
 - The company/competent person should have a Trade License issued by the Dubai Economic Department.
 - The company/competent person should have insurance coverage for professional liability.
 - Any other requirements issued by the center.
- 4- A accredited third party shall issue a certificate of safety after due examination and test, and only after any repairs have been carried out, specifying the serial number, technical details, tests are done, safe working load ... etc. for each equipment.
- 5- The repairs identified by the accredited third party shall be carried out by the owner/occupier immediately.
- 6- If the accredited third party considers that the equipment is unsafe, the owner must be advised to cease use of the equipment and a report must be sent immediately to the Health and Safety Department.
- 7- Any re-rating of safe working load or any other condition stipulated for the safe operation shall be clearly indicated in the certificate.
- 8- Safe working loads shall be displayed on the equipment.
- 9- Compliance certificate shall be kept at the site.

10- Operators of lifting equipment such as cranes, hoists, forklifts, cradles, etc. used in factories, construction sites, residential and commercial buildings and other workplaces shall be certified by a third party accredited by Emirates International Accreditation Center (EIAC).

- 11- Workers involved in lifting operation such as signalperson / signalman and rigger shall be certified by a third party accredited by Emirates International Accreditation Center (EIAC).
- 12- Training institutes involved in training of the lifting equipment operators, riggers and signalperson / signalman shall be registered and approved by Knowledge and Human Development Authority (KHDA).
